Referee Selection: Host organized; Championship selection by coaches (using elimination process)

Seeding done by participating school designee. Monday prior to tournament ballots are sent out. Cannot vote for your own school. Each school **must** vote to be seeded.

Motion to accept the Basketball guidelines made by Jim Wilson, seconded by Robert Johnson. Motion passes.

Single-district conferences may do their own thing.

d. 2013/14 Tournament Site Selection and 2012/13 Site verification

Discussion about Barrow being included in host rotation for wrestling and XC. BF wondered about every site paying a certain amount annually to ease the "pain" from the years when a long trip is necessary. Question raised about whether Barrow would be willing to pay some money to help teams travel to Barrow. Some concern about whether a Barrow tournament might whittle down participation numbers even more. Further discussion about berths and how to hang on to them – tournament in Barrow may limit numbers due to travel costs which could damage likelihood of gaining a berth back. Tabled until March meeting.

Some discussion about 3A basketball tournament in Anchorage. Pros/Cons. Do it this year in ANC with plan to continue for the 3rd year unless something changes in March.

- **e.** Website Development: Brad Potter (ASAA) has agreed to design and has given a quote. LM says the quote is reasonable for the work. GM says Region 1 is getting first crack at Brad. LM willing to be Reg1 "web expert". Approximate initial cost: \$2500. Ed Lester makes motion to approve \$2000 additional expenditure for website development, Robert Johnson seconds, passed unanimously.
- **f.** State BB semi-final game venue. Unlikely due to the early morning semi-final game. GM says it is also a financial consideration with smaller crowds.

IX. New Business

- **a.** A.S.A.A. October/December Meetings report :
 - 1. Solo/Ensemble moved to May 6-7
 - 2. Mixed 6 Northwest was split
 - 3. Increased max number of basketball games/season for this year only
 - 4. State wrestling seeding: Proposal to use Trackwrestling program to seed. ASAA likes the program and next year it will be required. \$50/year/school to be a part. Host teams do pay a event fee. 4A tournament will be TW seeded and ASAA seeded and will compare to see how close. Every site will have to enter data.
 - 5. Track/Field Region 1 sites must notify BS by March 1 so berths can be assigned elsewhere if available.
 - 6. New Classification system: Timeliness has been a problem due to EED issues. Start FY15 Spring 2014 notifications. No change that year but they'd move the following year. Would be 3 years at a time with spring notification. GM presented an example of cycle. JE recommends that we use a 3 year average instead of a single year to eliminate the problem with a single "peak" year. BS will propose a 3 year average. GM also commented that this doesn't change the subtraction of 5th year seniors from enrollments and added that not many schools use this option.
 - 7. 8th grade participation: R1 has asked the 20 student limit (or 10/10) be bumped up to 30 students (15/15 by gender). Will be an action item. BS says R2 and R5 are others affected and R5 didn't seem too interested.
 - 8. Foreign students living with coach. Right now it's not allowed, but request is in to allow. (Region 1 opposes.)
